On the Impact of Oil Prices on Real Exchange Rates in Oil-Exporting Countries Globally recognized paper, garnering the titles of Highly Commended as well as Regional Winner (Middle East and Africa) from the Undergraduate Awards (currently under review in the OPEC Energy Review). Used panel data econometric analysis to identify the impact of oil price changes on the real exchange rate of dispersed oil-exporting countries. Controlling for other factors, it was identified that the more dependent a country is on oil exports, the higher the degree of positively correlated change to their real exchange rate.

Business Feasibility of Home Snagging and Surveying Services for KNOX Technical Services Constructed the marketing plan, growth prospect research, feasibility, tenancy and real estate investor legal protection measures, and synergies with the existing home maintenance division at KNOX Technical Services to facilitate the introduction of home snagging and surveying services by the firm to its target audience.

On the Environmental Impact of Shale Oil and Gas Extraction: A Study on Texan Counties' Air Quality Explored the effect of shale oil and natural gas production within the state of Texas on air quality by exploring the level of production's effect on the level of air pollutants. Found the surprising result that the level of production may negatively impact or fail to impact the level of air pollutants in Texas, meaning the primary effect of production is on water quality deterioration instead of air quality.

Investment Valuation of Emaar Properties P.J.S.C. Through the use of the Chartered Financial Analysts' investments valuation guidelines, produced an investment valuation of Emaar Properties P.J.S.C in 2017 to aid in Emaar's stock investment decision. Used common practices by financial analysts to perform an absolute and relative valuation of Emaar, as well as disclosing the investment risks and growth prospects to show why Emaar at the time was a good investment choice.

Natural Resources and Economic Development in the Middle East: The Role of Institutions Econometric Analysis of the role of various institutions and their effect through natural resources on economic development and growth within the Middle Eastern region. Uncovered a globally-unrepresentative relationship, likely to the effect of the inclusion of the GCC region within the dataset.

Relationship between Educational Quality and Land Prices in Dubai Used panel data econometric analysis to explore the relationship between the educational quality of schools in Dubai with nearby land prices. It was found, after controlling for other factors, that land prices in Dubai were much less affected by nearby schooling quality than US land due to the lack of school districts in Dubai. Expanded this paper to explore the real estate market from a financial standpoint and through hedonic price regressions in the UAE and critiqued the Open Data policy.

The Interaction between Poverty and Inequality on GDP per Capita Through two-stage least squares panel data econometric analysis, the interaction between poverty and inequality on a country's GDP per capita was explored. The general consensus is that the more unequal the wealth distribution is in a country, the higher its poverty rate and lower its GDP per capita

Ethical Evaluation and Impact of Johnson & Johnson's Cancer-Causing Talc-based Products Thoroughly outlined and evaluated the impact of Johnson & Johnson's cancer-causing talc-based products on society, and created a full-fledged strategy to avoid its occurrence in the future.

Restructuring of Temasek and Dome in the UAE Investigated the micro and macro environment of Temasek in the UAE, and set a detailed business restructuring strategy to ensure future profitability and sustainability.
