# Professor Peter Danchin University of Maryland Carey School of Law 2006 to present

Peter Danchin is the Associate Dean for Research and Faculty Development, Jacob A. France Professor of Law, and Co-Director on the International and Comparative Law Program at the University of Maryland Carey School of Law. He holds a B.A. and LL.B with first class honors from the University of Melbourne where he was Editor-in-Chief of the Melbourne University Law Review, and a LL.M. and J.S.D. from Columbia Law School where he was a Bretzfelder International Law Fellow.

Professor Danchin was a foreign law clerk to Chief Justice Arthur Chaskalson of the Constitutional Court of South Africa, worked as a foreign associate at the New York law firm Skadden, Arps, Slate, Meagher and Flom, as an associate at the Australian law firm of Allens Arthur Robinson. From 2000-2006 he was a lecturer and director of the human rights program at Columbia University's School of International and Public Affairs.

His areas of interest include international law, human rights, comparative constitutional law and legal theory. His scholarship focuses, in particular, on critical approaches to the right of religious freedom in international legal, political, moral, and theological thought.
