Next Steps - Complete by Friday, August 25th

Timing of Disbursements

- ➤ Your registration status will update in the financial aid system 1-2 days after you register in SSOL.
- Financial aid will disburse from the financial aid system and be applied to your University student account (1-2 days).
 - > Tuition and fees, including health insurance, covered by your funding
 - ➤ U.S. Citizens/Permanent Residents stipend issued via direct deposit 2-3 days after being applied to your account.
 - ➤ International stipend issued via direct deposit via payroll the Friday following funding posting to your University account

Most students will receive their stipend funding by the end of next week.



Your Responsibility

- > Rent
- > Student Activities Fee: \$45 each semester
- ➤ Document Fee: \$105 one-time, first semester
- **➤** Language Course Fees
- ➤ Late Registration Fee: \$100
- ➤ Late Payment Fee: \$150 (first assessment), 1.5% of balance monthly
 - > if related to any of the above categories or during self-funded semesters
- ➤ Withdrawal Fee: \$75
